# **Task Force Updates**

- The last meeting of the UPEI Sexual Violence Prevention and Response Task Force took place on Friday, September 29th. The majority of the meeting consisted of reviewing the working draft of the policy and the finalizing decisions on proposed amendments. There was also some discussion of upcoming consultations.
- While there were some logistical complications initially which stalled decision-making on organizing campus consultations, the date for the first in-person consultation session has been set for Wednesday,
   October 18th from 12:30-1:30pm in McMillan Hall (Student Centre). There

will be a few short informative presentations to start off the event, followed by roundtable discussions with a facilitator at each table who will be responsible for encouraging and moving along conversation while ensuring that feedback and input is recorded on the brown paper provided at each table. There will also be information booths from both internal and external organizations, and refreshments will be provided. I STRONGLY ENCOURAGE ALL COUNCILLORS TO ATTEND!!!!

• The interview process for the Student Assistant has been completed, with Jackie and myself sitting on the hiring board, and after much deliberation, Kimberly Wishart Chu Foon has been selected as the new Student Assistant for the Task Force. Kimberly is a PhD student here at UPEI with extensive experience in the realm of research and will be a tremendous asset to the work of the Task Force. She has been working this week at implementing the suggested amendments of the Task Force into the policy document and helping prepare for the consultation session next week.

Premier's Action Committee on Family Violence Prevention Youth Engagement Working Group

• I participated in my second meeting as a UPEI representative for the PACFVPYEWG. I provided a presentation to the group on the work we're doing here at UPEI in the realm of sexual violence prevention. The committee was very excited about the work that we're doing and members enthusiastically agreed to help facilitate the consultations next Wednesday.

**CASA Policy Work** 

• I have been continuing work on my policy reviews with the Federal Policy Committee. The revised version I wrote for Policy Q:10 on

Integrating Federal and Provincial Student Loan programs was officially passed in committee yesterday.

- I continue to work with Conner Peta of the University of Lethbridge on Policy A30.4 on Exempting Parental Income from the CSLP Needs

  Assessment. Our preliminary ideas for amendments to the policy were approved and we're in the research and writing process now for the draft.
- I have been doing some background research in preparation to bring something forward to the committee regarding a potential new policy statement I wish to write regarding students and EI eligibility, in an effort to resolve some of the issues our students have identified regarding the new Career Connect program.
