1-1 CALL TO ORDER: The meeting was called to order at 7:04 pm.

2-1 APPROVAL OF THE AGENDA: Agenda was approved with modifications.

3-1 APPROVAL OF THE MINUTES: Minutes were approved with modifications.

#### REPORTS

#### **4-1 PRESIDENT**

Hello to everyone here tonight, my report is actually quite short so I'll try to skim over it as opposed to reading it out loud.

A. Act as the Chief Executive Officer and official spokesperson of the UPEI SU;

I appeared on Compass Monday night regarding the storm closure that day, but have not been required to speak on behalf of the UPEI Student Union in any other situations. However, I did speak on behalf of the student body in a meeting with:

- Jackie Podger (VP Administration & Finance)
- Greg Clayton (Director, Facilities Management)
- Glenda Clements-Smith (Director, Integrated Communications)
- Nicole Phillips (Manager, Communications)
- Roger \_\_\_\_\_ (Shipping & Receiving)
- two representatives of the AVC

This meeting was regarding the storm closure procedures and I raised a couple of concerns that we would like to see addressed. The first concern was the decision to close vs. to delay in the case of a storm. I supported a revised procedure presented by Nicole Phillips which advocated for a delay should there be any – and I mean *any* – hesitation to close completely.

The other concern I raised was around the Student Centre. In my three years on the executive team, I have seen this decision vary depending on whose working and what they think is "protocol" so I requested that the revised procedure for storm closure include a section referring to the Student Centre being left unlocked for the entirety of that day in case any students are stuck on campus. Jackie Podger fully agreed, as did everyone around the table and I am confident that this will be something that is written and referred to, not just agreed upon verbally year after year.

Since our last meeting, I've heard there are still concerns from our Bachelor of Education students so I've asked to meet with Andrea Avery who is the President of the B.Ed Society. I also asked if she knew our Education Rep - Robyn Christensen and offered to connect them if not.

Further to that, I requested that Facilities Management unlock and ensure that the wheelchair accessible doors to the Student Centre are working even in the case of a storm.

### B. Call meetings of the Executive;

We continue to meet every Monday morning at 11:30

C. Draft and propose a schedule of Council Meeting dates and General Meeting dates at the last Council meeting of the academic year;

This will occur shortly through the Policy Working Group.

I did want to mention that it may be worthwhile to look at reverting our election timelines back to February/March. It may be because so many senior administrators and directors are relatively new, but we seem to have confused them. Many staff, many faculty, and even some students are under the impression that candidates begin their terms as soon as they're elected. This makes life a little more confusing and to be honest, I worry that it means the last two and a half months of an executive's term is spent with one foot out the door. There are still plenty of things to accomplish before May 1st, and I want to make sure things still get done in years to come. This will be brought to Policy when we set dates but I wanted to mention it tonight in hopes that it would spark some feedback.

D. Serve as a member of the UPEI Senate;

The senate representatives will have a report for you this evening.

E. Serve as a member of the UPEI Board of Governors;

As I've mentioned before, I sit on the full Board of Governors as well as two different committees: Finance & Audit, and Executive.

The Finance & Audit committee met at the end of January to discuss the Enterprise Resource Planning (ERP) project among other things. One recommendation that came out of that meeting was the hiring of a new senior management position. The position would be Chief Information Officer, and they would be responsible for not only implementing the new ERP system, but also leading the University through a larger technology overhaul.

As the President of the Student Union, but also as a Board member, I see huge value in a position like this for three important reasons. Our legacy systems are becoming more costly and difficult to maintain, the university is headed towards more online courses and full programs, and the Student Union may finally see the Co-Curricular Record (or a more advanced concept with the same spirit) happen at UPEI. In difficult budgetary times, it would be really simple to say "no, we're not doing anything new because we can't afford it" but there needs to be a focus on investing in the projects that are going to move us forward. I believe this is a smart investment, as does the Board of Governors.

F. Act as liaison between the UPEI SU and groups outside the University;

Heckbert's Studio is back on campus this week, and they have expressed interest in offering a few more days of appointments on campus. This is great for us because every student that books an appointment provides

the Student Union Grad Week Committee with a \$5 kickback directly from Heckbert's. This is definitely a relationship we have cultivated and hope to continue.

Having Heckbert's in the Student Union boardroom was fantastic. They enjoyed themselves, we enjoyed having them here and the best part was the huge amount of students we saw each day!

Danielle and I also attended a pre-budget consultation meeting on Wednesday of this past week. It was a very successful and informative meeting and a practice we should continue in the future.

The Alumni event I have referred to a few times throughout the year is finally happening! Between us, Student Affairs, and the Alumni Office we've pulled together a March 13th event featuring 6 different UPEI alumni. It will take place at The Wave leading up to Wednesday night trivia and it will be fantastic.

H. Be enrolled in no more than nine (9) semester hours per Academic Semester during their Presidential term; Yup!

I. Act as liaison and ensure that adequate communication is maintained with the UPEI Administration;

Alaa and I continue to meet formally at least once a month, however we communicate most often by text, phone call, or e-mail. This seems to work for both of us and our conversations have begun to turn to a more detailed look at what this year's budget will mean for students. I will keep you updated as these conversations continue.

J. Pursue new initiatives to improve and expand the services of the UPEI SU;

Nothing new to report at this time.

K. Set strategic direction and objectives for the organization;

The executive have not yet met, but will meet, to discuss actions around the one year plan for now and into the transition phase for incoming executive.

We've also discussed the input survey Chelsea and her committee did, and she'll be presenting our plan of action later this evening.

L. Provide leadership and guidance to Council and staff;

Once again, I would like to acknowledge the hard work of our Chief Returning Officer and our Deputy Returning Officer. They work extremely well day-to-day with little to no supervision or guidance and I always know that the required tasks will be completed on time, and completed to the best of their ability.

Hiring boards will be occurring next week for VP Finance and VP Communications, and hiring boards for all other positions will begin in March.

Since the last meeting, our elections have wrapped up without too much trouble. I've encouraged Jessie and will encourage Vicki to apply for the CRO and DCRO positions for the upcoming academic year.

M. Attend CASA conferences as required, and;

Danielle and I will be attending the Canadian Alliance of Student Associations Annual General Meeting next month.

N. Perform other duties as required.

"Kandidate Karaoke" was a success.

Chelsea, Kendra and I cleaned the storage room in the back hallway of the Student Centre. Ten years of junk was hauled away in a 6x6x12 dumpster, a handful of items were donated to Habitat for Humanity, and the goodies will be featured in an upcoming Thursday night "Games Night" at The Wave with Chris and Spencer.

### 4-2 EXECUTIVE VP

Good evening council! I hope you all had a great break and were able to get some rest and catch up on your school work. Things have been very busy in the office with election season catch up from snow days. Before I get into my full report, I wanted to give council a quick update on the rink plan we had been pursuing. After consultation with UPEI's VP Finance, Jackie Podger and our new Athletics' Director, Billy Schurman, we successfully made all the arrangements to make the rink happen. Considering that we have very little winter left, we have made all the arrangements to ensure that the rink will happen next winter! We are very excited that the university was on board. We all acknowledged that we needed to make campus community a priority.

Because the rink wasn't something we could bring to reality this winter, both Jackie and Billy asked me to come back to you all and ask for ideas for the next 1.5 months that could create campus community before the year is over. We are in consultation with National Bank to set up our second lunch conference. Details on that to come.

We continue to work to on changes to the buddy program.

# **4-3 VP ACTIVITIES**

### Hello Council!

Here is my report for this meeting, following my job description:

1) Act as a liaison to all Sub-Organizations on campus

Society things that I've been involved with since our last meeting include making preparations for Nowruz (the Iranian New Year), the Chinese Spring Festival (which unfortunately had to be postponed until next Saturday due to weather), a movie showing with the CCSA, booking tables for the Aboriginal Society, communicating environmental initiatives to the Environmental Society, meeting about Pink Shirt Day (an antibullying campaign which I'm think the Rainbow Alliance will be getting involved with), meeting with University officials about holding a Rainbow Alliance lock-in, and starting to organize an improv night at The Wave with the theatre Society.

I have a new society to be ratified, which we will go over later in the meeting, and am currently talking to a few more about ratifying, which will hopefully be happening soon.

2) Act as chair of the Events Planning Committee

The events planning committee has been replaced by the VP Activities' Executive Committee, which has been meeting regularly in addition to being out in full force helping out with Frost Week.

3) Coordinate & facilitate all UPEISU concerts, events, and activities

Frost Week happened last week, and was a super fun time, if not a financial success. I'll be giving a more in-depth report on the highs and lows later on during the meeting, and would ask that you save any questions that you might have until then.

Candidate Karaoke was on Thursday, and was a blast. We had roughly half of the candidates in attendance, and everyone enjoyed themselves immensely. There was a small miscommunication which led to there being extra entertainment there, and I'll be sure to communicate better with the Wave's management in the future to ensure that that doesn't happen again.

4) Maintain communication between the UPEISU and Campus Organizations and Services

I've been talking with numerous people all across campus as part of my other duties mentioned in this report.

5) Oversee the operations of all UPEI SU Promotional Activities

This duty has been moved over to the VP Communication, but I meet with her and the promotions coordinator often to ensure that we're all on the same page.

6) Perform other duties as required

I've continued meeting with people from Student Affairs about the mental health initiative that the university is hoping to launch. It's coming along nicely, and you can expect to see it rolling out in March.

Grad Week Committee will begin to meet to plan Grad Week starting next week. I haven't been able to get any information from the University about the finances available to the committee yet, but we'll start making headway regardless.

**4-4 VP FINANCE** 

The Vice President Finance shall:

Be appointed upon the recommendation of Hiring Board:

- I've reapplied and been rehired for my job conditional on council approval.

Attend Executive Meetings as a voting member:

- I've attended both Executive Meetings since our last Council Meeting.

Ensure that the financial records of the UPEI SU are properly kept:

- I have been working on the budget for the budget committee. I also flew to Toronto to be a voting member
- on the board of trustees for our insurance trust fund. At the meeting we kept everything status quo with the exception of agreeing to try and grow the fund's membership and the steps necessary to do that.

Be responsible for keeping the Executive Committee informed of all issues which pertain to the finances of the UPEI SU:

- I've done this. I've also started working on the list of data that I would like to see collected from the businesses. It will be ready before the end of the school year.

Present financial reports as required by Council and to the members of the UPEI SU:

- I will be presenting the completed proposal for combining the wave and smoothie kiosk at the March 24th council meeting. I will also be doing a presentation on potential binding incentives for the wave staff at the March 10th council meeting. Finally, when the budget is drafted, I will be presenting it, and a report on current salary structures to council.

Receive and present to Council any requests for funding or donations as decided by the Executive:

There was one request for funding that came to me from the international student's society that I had to delay. They were getting T.D. bank to come in and do sessions and we already have an agreement with the National Bank. Once our agreement with the National Bank is over or T.D. doesn't work out, the funding will be reconsidered. I also received two additional requests for funding to be approved by council. The IVHQ volunteer abroad people sent me a request for \$619: \$370 for program costs and \$249 for registration fees. I recommend that we approve \$250 dollars for them. The student business case team sent me a request for \$1,000. I also recommend \$250 for them.

Oversee the operations of the UPEI SU Student Newspaper:

- The Cadre is doing very well. They have just released what, in my humble opinion, is the best video ever. They are also looking at upgrading the website and are about to go into talks with the budget committee for next year's funding. The Cadre for the remainder of this year is going to focus on its new format and working out the glitches that come along with that. At a later data they may look into partnering with a radio station or starting a podcast. Sidebar:
- Directors Insurance is director's liability insurance. That means that if any of the Executive is sued; the organization's insurance covers it, not each executive individually.

# 4-5 VP COMMUNICATIONS

Hellooooo Council,

I've basically been living, breathing, and being awake at all hours for Frost Week this last week, so forgive me if my report looks slightly scarce.

The Vice President Communications shall:

A. Be appointed upon the recommendation of Hiring Board;

B. Attend Council meetings as a non-voting member;Here I am!

D. Assume responsibility for all communications-related matters of the UPEISU; however, the President is the Chief Spokesperson of the student union;

- With elections going on, the website and Facebook have been being updated regularly with new information as it comes.

• Twitter: The SU has gained 24 followers since our last meeting so we're still steadily climbing! We've also had 37 retweets since our last meeting.

• Jon and I went through some different Twitter Analytics and one program, Tweroid, was particularly helpful. It shows when your followers are the most active so you can best judge when to put out your tweets, so I've been trying to schedule tweets within those timeframes to maximize our account's potential.

F. Be responsible for producing media releases, internal communications, and general information reports about the student union's activities. When appropriate, information will be distributed on campus and to local, provincial, and national media;

• No media releases since our last meeting.

G. Be responsible for maintaining a comprehensive calendar of events offered by the UPEISU;

•As mentioned, there are new calendars up for both The Wave and our SU/ Student Affairs calendar. Nicole sends me the info for the Wave, and KylahHennessey from SA sends me their information.

H. Provide a channel for, and solicit student input into all of the UPEISU's services: Nexus Yearbook, Cadre, The Wave, Entertainment, Mickey's Place, etc.;

4-6 SENATE

President's Report:

-The president just recently got back from Egypt and Turkey where he was strengthening relationships and making partnership.

-While he was in Egypt he and the Premier of Egypt met with 20 young people age 6-12. They were fluent in English.

- The premier read aloud one page of Anne of Green Gables and asked if there were any questions, expecting one....half an hour later the children were still asking questions about it.

Two of the questions were:

-"Who is the actress that played Anne in the movie?" –None of them knew, but the boy who asked did -What are the qualities that someone has to have to become a premier?

-The schools want to use the 2+2 model and they want Turkish students to come to UPEI for a 4 year nursing degree then go back

-When the student population of UPEI goes down it will help to have these relationships so those international students can come to UPEI during that time

-Alaa plans to make it possible to have a four year engineering degree here at UPEI (\$29 million) where the students can work with professors from every faculty (nowhere else in Canada does this)

-We need help from the government and fundraisers- It is going to happen, hopefully by next Sept

-One of our Alumni gave back by building an idea model for the School of Engineering (Alaa passed around the pictures). It was 4 floors and made of glass

-Dalton would be the new administration building

- The Vet College was supposed to receive \$1.3 million from NFLD- they will not get this money and now NB is unsure of what they will do for the AVC so the Premiers of all 4 of the Atlantic Provinces are meeting in April to discuss AVC plans

- This is difficult times in terms of budget

Motion Re-opened for Discussion

Moved: to approve that the President of the UPEI Faculty Association be invited to attend Senate in a nonvoting-capacity

-Question by Lisa: Should we amend the motion?

Should the President be able to "Serve" instead of attend; or at least have a voice but not a vote -Answer: Have to make sure that it is legal; the problem is the University Act (want to make sure we are following it)

-Clarification of the role should be put in the minutes

-The chair of the senate cannot change the position it has to be reviewed first

-He can invite the President of the UPEI Faculty Association to attend, but has to follow the University Act

-Don said they need to take baby steps while everyone is wondering why there is a hold up on this decision because in the Collective Agreement it says she can serve on the committee but

Don claims it does not say when we have to do this (no timeline)

-Everyone is confused about the definition of the word "Serve"- We need a dictionary folks!

-Susan wants to know what the timeline is and wants the motion and language to be clarified before she votes on the motion

- Don withdraws the motion and will give proper notification today for the next meeting about looking at the definition of serve and the motion described in the Collective Agreement

-The President of the Faculty Association expresses her displeasure about how it has been three months since the Collective Act has been signed and it will again be another month until it is resolved

Nominating Committee Report

-Patrice Drake will take the position of maternity leave replacement in the Nursing Faculty

-Hailey Lamb will be the grad student rep for service on this committee

-They are not sure why the committee structure has changed- cannot find it in the minutes from 2007 so they want to propose a new structure for the committee (1 Dean and 5 Faculty Members-Associate or Full Professors)

-Discussion said that there should be a member or dean of each faculty on the committee; therefore the committee needs to be larger (Christian and Miles) and wants to ensure equity of the schools and members

-Another option could be a dean of one school and then 5 different faculty members or to rotate the deans every year or elect them first

-Does there need to be a dean or not? (Informal vote) - No, as long as there is full professors (old) - Christian (used to be a dean on the committee)

-Majority of the senate said they would like to have both associate and full professors on the committee (Change the Motion)

4-9-5 AVC

Recently, a decision made by the AVC dean has been brought to light. It is believed that cuts being made right now will mean the loss of services in the VTH in the area of Wildlife and Exotic animal treatment. Therefore, the wildlife team will be eliminated, a cut that will take away opportunities for student volunteers to gain knowledge and experience in the area of wildlife treatment. Also lost with this cut to services, is the local zoo/exotic rotation previously offered to 4th year AVC students. Along with this, the department is also forced to cut its internship program. The wildlife team volunteer program has drawn praise from many students who are now expressing their dissatisfaction with the recent decision. The Wildlife rotation had been one of the more sought-after rotations offered at the school, the loss of which, and forces students to organize external rotations at other teaching hospitals / zoos. Travel, accommodations and other associated costs are out of pocket for students, and external zoo/exotics rotationally very competitive. SAVS and class representatives have been meeting all week with the dean and associate dean with mixed results.
