4-2 PRESIDENT

Hi Council,

Here are some highlights from the past two weeks:

- Attended the School Closure Debrief session. It was a good venue for campus stakeholders to share their concerns and suggestions for school closures. When UPEI had been alerted to the message, it reacted calmly as the threat in the message was deemed not credible. However, because of the circumstances across the province and the good health of students, it decided to close the campus. One interesting piece of information that came out of the meeting: the threat that was sent to the RCMP was not actually faxed by the perpetrator; instead, it was emailed somewhere that would fax it to the RCMP.
- Attended the Professor Emeritus Senate Committee.
- Attended a CASA Graduate Council Meeting, where we finalized our edits in time for CASA's Advocacy Week which will be taking place in 2 weeks.
- Attended a meeting with Kaylee between the Panther Pantry and the UPEI administration. We successful negotiated for the use and renovation of the kitchen space in Main Building, and will be contributing some funding toward the project.
- I attended Y-Day with John. The day was to gather youth perspectives regarding what the government could do to improve life for youth on PEI.
- We concluded our by-election on Wednesday. The unofficially successful candidates are Justin Clory (Arts Representative), Will McGuigan (Business Representative), and Erin McNeill (Senate Representative).
- Met with Treena Smith from Student Affairs about securing a block of counselling time for AVC students.
- We hosted our AGM, which included the presence of CBC.
- Attended a Policy Committee meeting, at which we discussed the
 potential change to the election process for the Accessibility
 Representative position. We will be bringing this back to Council for a
 brief discussion.
- Hosted an AVC Advisory Committee Meeting. We are looking at two potential events in November and January.
- With respect to labour negotiations, some possible good news: there was a meeting Friday regarding the Pension Plan proposal. From what I understand, faculty were voting Friday and will be voting tomorrow to accept or reject the plan.
- The deadlines for the Mental Health Initiatives Fund and the Inspiring Innovation Fund have been approved. The latter was adjudicated at the

last NIFD meeting, and the former will be adjudicated some time this week or next.

Question 4: "I found the Governance at the Student Union presentation to be." A majority of councillors answered that this presentation was moderately useful.

Question 5: "Following the governance presentation, I felt I understood the governing documents, responsibilities of councillors, Council, the executive."

A majority of councillors answer that they did understand the governing documents, responsibilities of councillors, Council, and the executive after the governance presentation.

Question 6: "I found the Campus Trust presentation to be." A majority of councillors answered that the Campus Trust presentation was very useful.

Question 7: I found the Daily Operations and Financial Statements presentation to be:. Most councillors answered that the Daily Operations and Financial Statements presentation was very useful.

Question 8: "I found the SWOT Analysis and Discussion to be." A majority of councillors answered that the SWOT Analysis and Discussion was very useful.

Question 9: "I found the Return to Robert's Rules to be." A majority of councillors answered that the Return to Robert's Rules was moderately useful.

Question 10: "I found the Council Meeting to be." A majority of councillors answered that the Council Meeting was moderately organized.

Question 11: "I found the Councillor Transition Program session to be." Most councillors answered that the Councillor Transition Program session was moderately useful.

Question 12: "I found the accommodation to be." There was variance on the answers to question twelve. Many councillors indicated that they were neutral on the question or thought the accommodations were moderately bad.

Question 13: "I found the food at Brothers 2 to be." A majority of councillors answered that the food at Brothers 2 was very good.

Question 14: "Overall, I found Council Retreat to be." A majority of councillors found Council Retreat to be very beneficial.

President Hood contacted Cathy Rose, the Accessibility Services Coordinator at UPEI, for her thoughts on who should be eligible to run for the council position, Accessibility Representative. Cathy Rose suggested that we continue with the practice we have be using, which includes candidates for Accessibility Representative must be registered with Accessibility Services, and any full-time student may vote for the representative. Rose mentioned that we should be aware that having people disclose that they are registered with accessibility services may be discriminative because this information is undisclosed to the public. President Hood, with this comment in mind, suggested that instead of requiring students "must be" registered with Accessibility Service, they "should be" registered in order to run for the position.
